

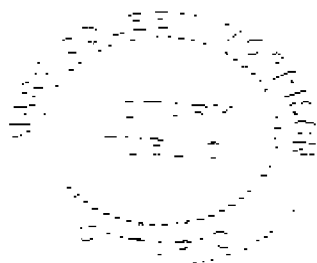



3 - The articles of the above-named corporation are amended as follows:

- a. The name of the Corporation be changed to March Networks Corporation;
- b. The issued and outstanding common shares of the Corporation be consolidated or changed into Common Shares of the Corporation on the basis of one (1) common share for each four (4) common shares presently issued and outstanding;

The directors and proper officers of the Corporation be and they are hereby authorized to take all such action and execute and deliver all such instruments and documents as may be necessary or desirable to implement the foregoing, including such amendments to such instruments and documents as they believe may be necessary to effect the foregoing; PROVIDED HOWEVER THAT the directors may revoke this resolution at any time before Articles of Amendment are filed without approval of the shareholders being required.
