AND WE HEREBY covenant that we have the full right to convey the interest assigned by this Assignment, and we have not executed and will not execute any agreement in conflict with this Assignment;

AND WE HEREBY further covenant and agree that we will, without further consideration, communicate to the Assignee, its successors and assigns, any facts known to us respecting the aforesaid invention and testify in any legal proceedings, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said Assignee, its successors or assigns in the aforesaid invention, execute all divisional, continuation, reissue and re-examination applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors and assigns, to obtain and enforce proper patent protection for the aforesaid invention in any country, it being understood that any expense incident to the execution of such papers shall be borne by the Assignee, its successors, and assigns.


