

ASSIGNMENT OF CLAIMS

For valuable consideration, the receipt of which is hereby acknowledged, BSQUARE Corporation, a Washington corporation, hereby assigns, transfers and delivers to Citadel Wireless, Inc., a California corporation, all of its right, title and interest in the promissory note dated June 30, 2001 from Bodycom, Inc. to BSQUARE Corporation, the underlying monetary obligation represented by such note and the security agreement dated July 24, 2001 which secured such note, which constitute the total of all outstanding debts claimed by BSQUARE.

In exchange for the assignment Citadel Wireless, Inc. agrees to transfer and deliver to BSQUARE Corporation a total of 500,000 shares of common stock of Citadel Wireless, Inc.

BSQUARE Corporation agrees to execute any and all documents reasonably requested by Citadel Wireless, Inc. to effectuate and perfect the assignment hereunder, including the execution and delivery of a UCC-2 Statement assigning BSQUARE Corporation's security interest for the amounts owed and assignment of any claim filed in connection with the bankruptcy proceeding of Bodycom, Inc.

BSQUARE Corporation and Citadel Wireless, Inc. hereby mutually agree to use their best efforts to complete a standard services agreement between the two firms to complete and develop a wireless handset to be delivered before October 31, 2002. BSQUARE will be providing the engineering services for this contract, the value of which is expected to exceed \$500,000.
