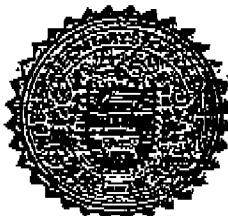

CERTIFICATE OF MERGER

CORVAS INTERNATIONAL, INC. INTO DENDREON SAN DIEGO LLC

Pursuant to Section 264(c) of the Delaware General Corporation Law and Section 18-209 of the Delaware Limited Liability Company Act, Dendreon San Diego LLC, a Delaware limited liability company and the surviving limited liability company in this merger (the "Merger"), files this Certificate of Merger and does hereby certify the following:

1. The constituent business entities (the "Constituent Entities" and, each individually, a "Constituent Entity") and their states of domicile are Corvas International, Inc., a Delaware corporation, and Dendreon San Diego LLC, a Delaware limited liability company.
2. The Constituent Entities are parties to an Agreement and Plan of Merger dated February 24, 2003, as amended by a Waiver and Amendment dated June 12, 2003 (the "Merger Agreement"). 5. The Certificate of Formation of Dendreon San Diego LLC, a Delaware limited liability company, as amended to date, shall be the Certificate of Formation of the surviving limited liability company.
6. The executed Merger Agreement is on file at the principal place of business of the surviving limited liability company at 3005 First Avenue, Seattle, Washington 98121.
7. A copy of the Merger Agreement will be furnished by the surviving corporation on request and without cost, to any member or stockholder of a Constituent Entity.
