ASSIGNMENT

WHEREAS, We, Dale Lookholder of the City of Santa Clarita, State of California; Christopher B. Caston of the City of Glendale, State of California; Joaquin G. Serrano of the City of Los Angeles, State of California; and Theodore Lookholder of the City of Los Angeles, State of California, have invented a new and useful "Stamping Device" (Docket No. 99038D1) for which we have this 24 day of September, 2002 executed application papers for United States Letters Patent thereon; and

WHEREAS, Glendale Rubber Stamp & Printing Co., a California corporation, having a place of business at Glendale, California (hereinafter, together with any successors, legal representatives or assigns thereof, called "Assignees") is desirous of acquiring the entire and exclusive right, title and interest in and to the said invention and in and to any Letters Patent which may be granted and issued therefor in the United States and throughout the world;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to me in hand paid, and other good and valuable considerations, the receipt of which is hereby acknowledged, we Dale Lookholder, Christopher B. Caston, Joaquin G. Serrano, and Theodore Lookholder by these presents do hereby sell, assign, transfer and set over to Assignee, Glendale Rubber Stamp & Printing Co., its successors and assigns, the entire and exclusive right, title and interest in and to the said improvements, and said application and all divisions, substitutes and continuations thereof, and all United States Letters Patent which may be granted thereon and all reissues and extensions thereof and all priority rights under the International Convention for the Protection of Industrial Property for every member country, and all applications for patents (including related


rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said improvements in any foreign countries, and all patents (including all extensions, renewals and reissues thereof) granted for said improvements in any foreign countries; and we Dale Lookholder, Christopher B. Caston, Joaquin G. Serrano, and Theodore Lookholder hereby authorize and request the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all patents for said improvements to Assignee, Glendale Rubber Stamp & Printing Co., in accordance with the terms of this assignment.

AND WE HEREBY covenant that we, Dale Lookholder, Christopher B. Caston, Joaquin G. Serrano, and Theodore Lookholder have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute any agreement in conflict herewith;

AND WE HEREBY further covenant and agree that we will communicate to Assignee, Glendale Rubber Stamp & Printing Co., any facts known to us respecting said improvements, and testifying in any legal proceeding, sign all lawful papers, execute all divisionals, continuations, substitute and release applications, make all rightful oaths and generally do


everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.


