provisional, substitution, continuation, divisional, reissue, reexamination, or corresponding foreign or international patent applications;

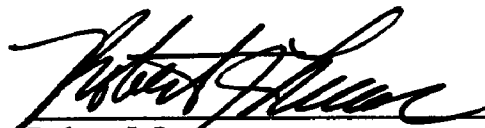

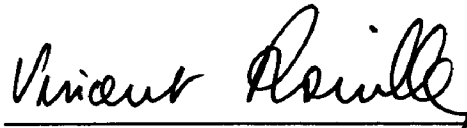
