WHEREAS, WE, John W. Devitt, a citizen of the United States, residing at 6898 Alleghany Trail, Maineville, Ohio 45039, Mark E. Voelker, a citizen of the United States, residing at J24 Forest Heights, Butler Pennsylvania 16001, David R. Wade, a citizen of the United States, residing at 7898 Woodstone Drive, Cincinnati, Ohio 45244, and Michael J. Garter, a citizen of the United States, residing at 6602 St. Andrew's Cross, Apt. E, Liberty Township, Ohio 45044 (hereinafter referred to as "ASSIGNORS"), have invented Methods and Systems for Distinguishing Multiple Wavelengths or Radiation in a Detection System, for which we have executed an application for Letters Patent of the United States, on even date herewith, and for which a Provisional Application was filed on November 8, 2002 as Serial No. 60/424,863; and

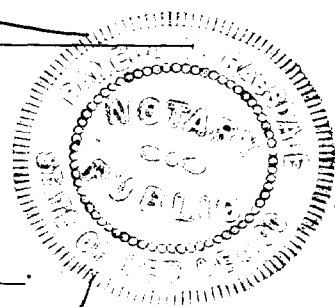
