WHEREAS, we, Donna Riggs Chapman of Burlington, KY; John Lemert of Fort Wayne, IN; and Jeffrey Walker of Fort Wayne, IN have made a certain invention entitled APPARATUS FOR TANNING FEET AND ANKLES, for which an application for Letters Patent of the United States (the "Application") is being filed, the Declaration for which we have executed on the same date as this Assignment;

In addition, we hereby authorize and request the Director of the U.S. Patent and Trademark Office, or other proper Officer, to issue such Letters patent or any of them to Golden Feet the assignee of our entire right, title and interest in and to the same for the sole use and benefit of Golden Feet and its successors and assigns.

And we further covenant and agree that we will, at the request

of Golden Feet, execute such other and further assignments and assurances of title as are proper to fully convey the interests herein sought to be conveyed; that we will, at the request of Golden Feet, execute such application papers and related documents as may be desired by it for the filing of any division, continuation, continuation-in-part of the Application herein conveyed, and will execute, at the request of Golden Feet, such supplemental oaths, declarations, preliminary statements or other papers as are necessary and proper to obtain Letters Patent for the invention herein conveyed.


