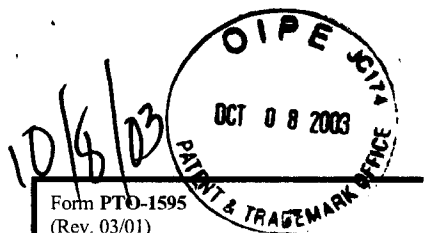

KG and Assignee on or about the date hereof, the receipt and sufficiency of which is hereby acknowledged by Assignor, hereby sells, assigns, and transfers to Assignee, its successors and assigns, the entire and exclusive right, title and interest worldwide in, to and under the Assigned Rights, to be held and enjoyed by Assignee for its own use and enjoyment including the right to prepare, file, prosecute, maintain, defend and enforce the Assigned Rights, and for the use and enjoyment of its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made, together with all claims for damages by reason of past infringement of the Assigned Rights, with the right to sue for and collect on such claims for its own use and enjoyment, and for the use and enjoyment of its successors and assigns.




