

ASSIGNMENT

I, Thayne B. Haney of 1463 South Evalin Circle Syracuse, Utah 84076 have invented a method and apparatus entitled CORNER FOR A TABLE TOP CONSTRUCTED FROM BLOW-MOLDED PLASTIC, hereinafter called the "invention."

This assignment and agreement shall be binding upon my heirs and legal representatives.

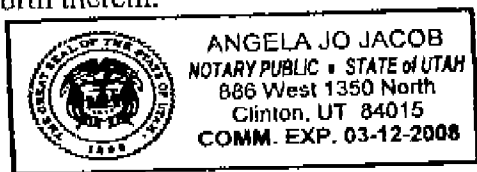
