## ASSIGNMENT

Further, I agree to execute all papers and to give such lawful testimony and to perform such other lawful acts as said T-Mobile Deutschland GmbH, its successors and assigns may require to enable it or them to procure a Letters Patent on said invention or reissues or

extensions thereof in the United States of America, and/or to hold, enforce or convey said Letters Patent, reissues or extensions.
