ASSIGNMENT OF PATENT

Further, and without limitation, Assignor assigns, sells and conveys to Assignee any and all rights of Assignor, express or implied, legal or equitable, in and to all licenses or use agreements relating to the above-described patent, including, without limitation, all income, royalties, damages, claims and payments now or hereafter due or payable with respect thereto. Assignor hereby authorizes Assignee to apply for patents of foreign countries for said inventions, and to claim all rights of priority without further authorization from Assignor; and Assignor hereby agrees to execute all papers useful in connection with said United States and foreign applications, and generally to do everything possible to aid Assignee, its successors, assigns and nominees, at their request and expense, in obtaining and enforcing patents for said inventions in all countries; and Assignor hereby requests the Commissioner of Patents and Trademarks to issue all patents granted for said inventions to Assignee, its successors and assigns.

Assignor warrants and represents that it is conveying to Assignee good legal and equitable title to the aforesaid, free and clear of all mortgages, liens, claims, encumbrances and other restrictions. Assignor agrees to execute all papers and perform such other acts, as Assignee may deem necessary to secure for Assignee and/or its successors, assignees or designees, the rights herein assigned.


