(WHICH INCLUDES AMENDING THE NAME OF THE CORPORATION)

COMPRESSION TELECOMMUNICATIONS CORPORATION, a Maryland corporation, whose Articles of Incorporation were approved for filing on the 24th day of February, 1984, hereby certifies to the State Department of Assessment and Taxation that:

FIRST: The name of the corporation (which is hereinafter referred to as the "Corporation") shall be changed to "ECTel, Inc."

SECOND: Article FOURTH: shall be stricken in its entirety and the following language shall be inserted in lieu thereof:
