**ASSIGNMENT**

WHEREAS, we, the below named inventors, have invented certain new and useful inventions disclosed in a application for United States Letters Patent entitled "METHOD AND APPARATUS FOR ASSISTING WITH PLAYBACK OF REMOTELY STORED MEDIA FILES," executed by Robert D. We will execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect and fully vest the forgoing rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

We will communicate to ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to me respecting the inventions and any improvements; and, at the expense of ASSIGNEE, will testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything reasonably necessary to vest title in ASSIGNEE and to aid ASSIGNEE, its successors, assigns and legal representatives in obtaining and enforcing protection for said inventions in all countries throughout the world.

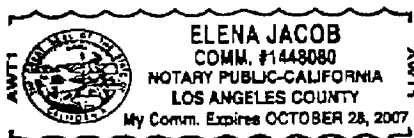

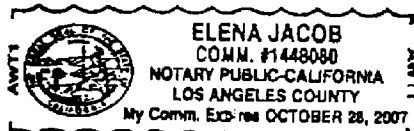
