Assignment of Invention

WHEREAS, WE, **Fabienne CHATEL-PELAGE** of 222 North Columbus, Appt. 2102, CHICAGO IL 60601 (USA) ; **Gilles LEBAIN** of 33 rue du Colonel Fabien, 94320 THIAIS (France) ; **Claire SZULMAN** of 3 rue Langlois, 92190 MEUDON (France), **Etienne WERLEN** of 85 boulevard Pasteur, 75015 PARIS (France) respectively, have invented certain new and useful improvements in: **HEAT EXCHANGER WITH BRAZED PLATES** for which: (a) an application for Letters Patent was filed on DEC. 21, 2001, having Application No. 10/250,434 ; or (b) for which an application for a United States patent was executed on _____, and

WHEREAS, **L'Air Liquide Société Anonyme à Directoire et Conseil de Surveillance Pour l'Étude et l'Exploitation des Procédés Georges Claude** (hereinafter referred to as "ASSIGNEE") having a place of business at: 75 Quai d'Orsay, 75321 PARIS Cedex 07, FRANCE, desires to acquire the entire right, title and interest in and to said invention, and in and to any Letters Patent that may be granted thereof in the United States and its territorial possessions;

Further, we agree that we will communicate to said ASSIGNEE or its representatives any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions.




