AND I HEREBY warrant and covenant that I had or do have the full right to convey the entire interest herein assigned at the time of the sale, assignment and transfer;



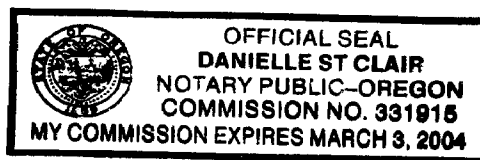
