ASSIGNOR further covenants that ASSIGNOR will promptly provide, upon written request, ASSIGNEE with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents in foreign countries as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof.

ASSIGNOR was deceased on August 11, 2001, as indicated on the Death Certificate dated August 14, 2001 attached hereto, and this Assignment is signed by Emma J.
