CONFIRMATORY ASSIGNMENT

This CONFIRMATORY ASSIGNMENT (this "Agreement") is made and entered into as of June 16, 2003, by and among (i) Alcatel USA Marketing, Inc., a corporation organized under the laws of the State of Delaware ("Alcatel Marketing"), (ii) Alcatel USA GP, Inc., a corporation organized under the laws of the State of Delaware ("Alcatel GP"), and Alcatel USA LP, Inc., a corporation organized under the laws of the State of Nevada ("Alcatel LP"), and (iii) Alcatel USA Sourcing, L.P., a limited partnership organized under the laws of the State of Texas ("Alcatel Sourcing").

WITNESSETH:

WHEREAS, Stanford Telecommunications, Inc., a corporation organized under the laws of the State of Delaware ("Stanford"), whose full post office address is 3400 West Plano Parkway, Plano, Texas, 75075, U.S.A., is the assignee and owner of record in and to all of the patent applications and granted patents set out in Schedule 1 attached hereto;

WHEREAS, effective May 23, 2003, Stanford, merged with and into Alcatel Marketing;

WHEREAS, Alcatel Marketing has assigned an undivided partial interest in and to the inventions identified in the attached Schedule 1 whether patentable or not, including all subject matter as described in the patent applications and in the granted patents listed in the said Schedule 1 (all such inventions and subject matter hereafter being referred to as "Inventions"), any future or existing applications for patent resulting from such Inventions, including all divisions, continuations, continuations-in-part, re-examinations, reissues and extensions, and any rights of priority resulting from the filing of any and all applications for patent for said Inventions under international conventions, treaties or otherwise and any future or existing granted patents resulting from such applications for patent (the whole collectively hereafter being referred to as the "Patent Assets") to Alcatel GP;

WHEREAS, contemporaneous to the said assignment of the undivided partial interest to Alcatel GP, Alcatel Marketing has assigned the whole of the remaining undivided interest in and to all of the Patent Assets to Alcatel LP; and

WHEREAS, subsequent to the assignments of the Patent Assets from Alcatel Marketing to Alcatel GP and Alcatel LP as aforesaid, Alcatel GP and Alcatel LP have each assigned all of their respective right, title and interest in and to all of the Patent Assets to Alcatel Sourcing whose full post office address is 3400 West Plano Parkway, Plano, Texas, 75075, U.S.A.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Alcatel Marketing, Alcatel GP, Alcatel LP and Alcatel Sourcing hereby covenant, agree and declare as follows:

1. Alcatel Marketing confirms that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it did transfer and assign to Alcatel GP an undivided partial interest in and to all of the Patent Assets, the same to be held and enjoyed by Alcatel GP, and by its assigns and successors, as fully and entirely as the same would have been held and enjoyed by Alcatel Marketing had this transfer and assignment not been made;

2. Alcatel Marketing confirms that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it did, contemporaneous to the said transfer and assignment of the undivided partial interest to Alcatel GP, transfer and assign to Alcatel LP the whole of the remaining undivided interest in and to all of the Patent Assets, the same to be held and enjoyed by Alcatel LP, and by its assigns and successors, as fully and entirely as the same would have been held and enjoyed by Alcatel Marketing had this transfer and assignment not been made;

3. Alcatel GP confirms that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and subsequent to the transfer and assignment of the Patent Assets from Alcatel Marketing to Alcatel GP as aforesaid, it did transfer and assign to Alcatel Sourcing its entire interest in and to all of the Patent Assets, the same to be held and enjoyed by Alcatel Sourcing, and by its assigns and successors, as fully and entirely as the same would have been held and enjoyed by Alcatel GP had this transfer and assignment not been made; and

4. Alcatel LP confirms that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and subsequent to the transfer and assignment of the Patent Assets from Alcatel Marketing to Alcatel LP as aforesaid, it did transfer and assign to Alcatel Sourcing its entire interest in and to all of the Patent Assets, the same to be held and enjoyed by Alcatel Sourcing, and by its assigns and successors, as fully and entirely as the same would have been held and enjoyed by Alcatel LP had this transfer and assignment not been made.



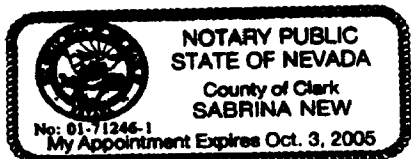


