


APPOINTMENT OF INVESTIGATOR AS AGENT

Appointment by the Howard Hughes Medical Institute (the "Institute") of Mark F. Bear, PhD, an investigator employed by the Institute, as its agent for the purpose of assigning certain rights to Brown University School of Medicine (the "University").

WHEREAS, the Institute and the University collaborate in the active conduct of medical research pursuant to an Agreement between them dated as of June 16, 1994 (the "Agreement");

WHEREAS, pursuant to the Agreement, the Institute has agreed to assign to the University the Institute's rights with respect to inventions, discoveries, improvements, and other intellectual property, whether patentable or copyrightable (each a "Subject Property"), conceived or reduced to practice in the course of the research program conducted under the Agreement by employees of the Institute;

WHEREAS, research conducted pursuant to the Agreement by Mark F. Bear, PhD while employed by the Institute at the University has resulted in the invention of a certain Subject Property entitled "Method for the Treatment of Mental Retardation," which is the subject of a patent application filed in the U.S. Patent and Trademark Office entitled "Method for the Treatment of Mental Retardation" on April 2, 2001 (the "Invention"), and the Invention is a Subject Property; and


WHEREAS, the Institute wishes Mark F. Bear, PhD to act as its agent for the purpose of assigning to the University the rights the Institute has in the Invention by reason of the research program conducted at the University,

NOW THEREFORE, the Institute hereby appoints Mark F. Bear, PhD as its agent for the purpose of assigning the rights the Institute has in the Invention by reason of the research program conducted at the University to the University in accordance with and subject to the conditions of the Agreement.


