ASSIGNMENT

WHEREAS, we, Michael Robert Lloyd Selbie, of New South Wales, Australia, residing at 4/5 Waiwera Street, McMahons Point New South Wales, 2060 Australia, and Bruce Gregory Biltoft, of New South Wales, Australia, residing at 7/89 Ridge Street, North Sydney, New South Wales, 2060 Australia, have invented new and useful improvements in FILTER CARTRIDGE MANIFOLD, for which an application for United States Letters Patent is executed by us concurrently herewith;

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt of which is hereby acknowledged, we, Michael Robert Lloyd Selbie and Bruce Gregory Biltoft agree that, when requested, we will, without charge to Memtec Limited but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable, or convenient to have assigned, sold and set over, and do hereby assign, sell and set over unto the said Memtec Limited for the territory of the United States of America our entire right, title and interest in and to said invention, as fully set forth and described in the specification prepared and executed by us preparatory to obtaining Letters Patent of the United States therefor; said interest of invention, application and Letters Patent to be held and enjoyed by the said Memtec Limited for its own use and behalf and for the use of its assigns and legal representatives to the full end of the term for which said Letters Patent may be granted as fully and entirely as the same would have been held by us had this assignment and sale not been made, and further state that any and all patents for said inventions be issued to Memtec Limited, its successors and assigns, or to such nominees as it may designate.



We hereby consent that a copy of this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file, or like document, which may be required in any country for any purpose and more particularly in proof of the right of Memtec Limited, its successors and assigns, to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.
