**WHEREAS**, I, Martin S. Nielsen, a citizen of Denmark, residing at Vadgårdsvej 17, DK-6830 Nørre Nebel, Denmark (hereinafter referenced as ASSIGNOR), has invented a certain new and useful invention entitled Remote Control Device And Method Of Configuration Of Such A Remote Control Device, U.S. Application Serial No. 10/433,216 for which an application for Letters Patent of the United States was filed on May 30, 2003, in the United States Patent and Trademark Office;

And I hereby agree to transfer a like interest, upon the request of said ASSIGNEE, his successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said invention; and to execute any papers by the said ASSIGNEE, his successors, assigns and legal representatives, deemed essential to ASSIGNEE'S full protection and title in and to the invention hereby transferred.
