

- f. Any and all rights in foreign countries under such applications and inventions, including the right to claim the priority date of the United States provisional application and the right to priority under such application under the International Convention.


Assignor hereby authorizes and requests the Commissioner of Patents to issue any and all such Letters Patent for said invention to said Assignee.
