ASSIGNMENT

Whereas, Rebecca U. Ruefer, having an address of 1455 Mt. Ellis Lane, Bozeman, MT 59715 (hereinafter "Ruefer") is an inventor of certain Patent Rights, as defined hereinafter;

Whereas, Bridger Biomed, Inc., a Montana Corporation having a place of business at 2430 North 7th Street, Bozeman, MT 59715 (hereinafter "Bridger") is the owner of the Patent Rights, by reason of Ruefer's employment by Bridger, and desires to confirm its ownership of these Patent Rights;

Whereas, in this Assignment the term "Patent Rights" shall mean any and all written, oral and visual ideas, concepts and inventions of Ruefer that are within the business and operations carried out by or on behalf of Bridger and that relate to any items manufactured by or for, or sold or distributed by, Bridger prior to the date of execution hereof, whether or not any such idea, concept or invention has been filed as a patent application or submitted by Ruefer to any attorney or other person for evaluation as to patentability; and any patents, any provisional patent applications, and any non-provisional patent applications, as well as any patents issuing on these applications worldwide, and all divisionals, patents of addition, continuations, continuations-in-part, reissues, renewals, registrations, confirmations, re-examinations, extensions, supplementary protection certificates, term extensions (under applicable patent law or regulation or other law or regulation), and certificates of invention of any patents or patent applications, in which Ruefer is a named inventor and which are within the business and operations carried out by or on behalf of Bridger and that relate to any items manufactured by or for, or sold or distributed by, Bridger prior to the date of execution hereof including, but not limited, to the patents and patent applications set forth on the attached Schedule;

Now, therefore for good and valuable consideration, the sufficiency of which is acknowledged, and the receipt of which is hereby acknowledged, Ruefer does hereby sell, assign and transfer, and confirm the sale, assignment and transfer, to the said Bridger of her entire right, title and interest in and to said Patent Rights, all inventions disclosed therein and any and all patents of the United States and of all other countries which may be granted for the said inventions.

Said Bridger, its successors and assigns, shall have, hold and enjoy the said inventions and said Patent Rights to its own use and benefit as fully and entirely as the same would have been held and enjoyed by Ruefer had this assignment and sale not been made, including without limitation the right to sue and recover for past infringement.

Ruefer represents and warrants that she has the full right, power and authority to execute, deliver and perform this Assignment. Ruefer shall retain no Patent Rights and shall assert no Patent Rights against Bridger, its successors or assigns.

Ruefer hereby authorizes and requests the Commissioner of Patents of the United States, as well as any officials of countries foreign to the United States, whose duty it is to issue patents, to issue any additional Letters Patent as may be granted on the said inventions to Bridger in accordance with the terms of this instrument.
