**ASSIGNMENT OF UNITED STATES PATENT APPLICATION**


WHEREAS, we, Paul L. Sinclair and Ganesan Gopal, of Manhattan Beach, California and Alameda, California, respectively, have invented certain new and useful improvements in **Partition Elimination on Indexed Row IDs**, Docket No. 11278, for which we have executed an application for Letters Patent of the United States on same date herewith, respectively; and


