UNITED STATES PATENT ASSIGNMENT

RECITALS

Koala hereby sells, assigns and transfers unto Bobrick Koala's entire right, title and interest in and to the Patents and in and to any division, continuation, continuation-in-part, reissue and extension of said Patents, together with any and all other rights in the Patents that Koala may have, all on the terms and subject to the limitations set forth in the Assumption Agreement.
2. Koala further sells, assigns and transfers unto Bobrick all right, title and interest, it may have, in and to any and all causes of action and rights of recovery for past infringement of the Patents.
3. Koala and Bobrick agree that this Assignment conveys to Bobrick no warranties or rights in addition to those expressly set forth in the Assumption Agreement.
4. The terms, covenants and provisions of this Assignment shall inure to the benefit of Bobrick, its successors, assigns, and/or legal representatives, and shall be binding upon Koala, its successors, assigns and/or other legal representatives.

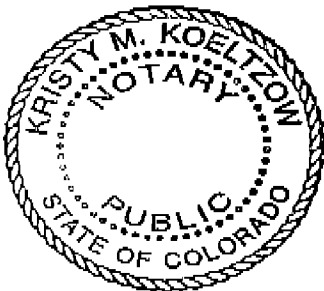

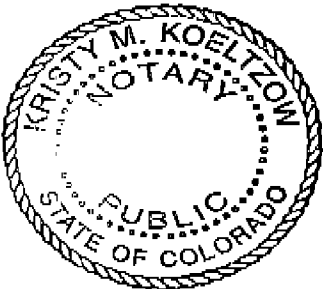
