ASSIGNMENT

WHEREAS, I, Victor Trifu, a citizen of Romania, residing at 111 Stackyard Drive, Mastic Beach, New York 11951 (hereinafter referred to as "ASSIGNOR"), have invented a RING DOWN INTERCOM, for which U.S. Patent Application Serial No. 10/652,865 was filed on August 29, 2003; and
