ASSIGNMENT AND AGREEMENT



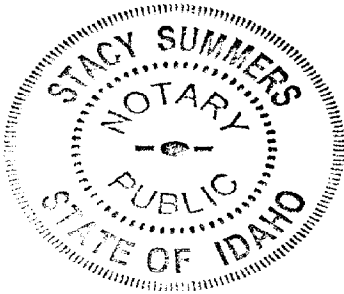
