

### **ASSIGNMENT**

WHEREAS, Douglas F. Reynolds, a citizen of the United States of America, residing at Bluffstone Cove, #5206, Austin, Texas 78758; Jeffrey Lewis Brandt, a citizen of the United States of America, residing at 801 Forest Trail, Cedar Park, Texas 78613; Aaron Bangor, a citizen of the United States of America, residing at 8518 Cahill Drive #39, Austin, Texas 78729; and Marc Andrew Sullivan, a citizen of the United States of America, residing at 13333 Humphrey Drive, Austin, Texas 78729; hereinafter called the "Assignors", have made the invention described in the United States patent application entitled "System and Method for Broadcasting Packetized Voice Messages", Attorney Docket No. 1033-LB1013 (SBC LB1013), for a full description of which reference is here made to an application for Letters Patent of the United States filed on February 6, 2004 and assigned Application Serial No. 10/774,057; and
