**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENT RIGHTS**

TERMINATION AND RELEASE dated as of July 9, 2004, from JPMorgan Chase Bank (as successor-in-interest to The Chase Manhattan Bank), a New York banking corporation, as Administrative Agent (the "Agent") for certain banks and other financial institutions, to CMS Gilbreth Packaging Systems, Inc., a Delaware corporation, with its principal place of business located at 3001 State Road, Bristol Township, Bucks County, Pennsylvania ("CMS Gilbreth Packaging Systems").

WITNESSETH:

WHEREAS, pursuant to the [Amended and Restated Subsidiaries Security Agreement, dated as of July 8, 1999, made by the Grantors (as defined therein), in favor of the Agent (the "Collateral Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Patents (as hereinafter defined);

WHEREAS, the Collateral Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on October 23, 2001, at Reel 12252 and Frame 0632; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Patent.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Patents," as used herein, shall mean all of CMS Gilbreth Packaging Systems' right, title and interest of every kind and nature and to all patent registrations and patent applications, including, without limitation, each patent listed on Schedule A attached hereto.

2. Release of Security Interest. The Agent, on behalf of itself, its successors, legal representatives and assigns, hereby terminates, releases and discharges fully its Security Interest in the Patents, and any right, title or interest of the Agent in such Patents shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
