ASSIGNMENT

WHEREAS, I, WILLIAM H. EBY, a citizen of the United States, residing at 4763 Panorama Drive, Panora, Iowa 50216, KEVIN W. MATSON, a citizen of the United States, residing at 3304 Jewel Circle, Ames, Iowa 50010 and JOSEPH R. BYRUM, citizen of the United States, residing at 913 31st Street, West Des Moines, Iowa 50265 are the inventors of an invention in SOYBEAN CULTIVAR SO30150 for which we have executed an application for Letters Patent of the United States, of even date herewith; and

WHEREAS, STINE SEED FARM, INC., incorporated in the state of Iowa, with a place of business at 2225 Laredo Trail, Adel, Iowa 50003 and MONSANTO TECHNOLOGY LLC, a Delaware limited liability company with a place of business at 800 North Lindbergh Blvd., St. Louis, Missouri 63167, have entered into an Agreement dated December 8, 1997, wherein both companies are hereby assigned a joint and undivided interest in the entire right, title and interest in, to and under the said invention and the said application;

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I will communicate to said STINE SEED FARM, INC. and MONSANTO TECHNOLOGY LLC, its successors, legal representatives and assigns, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said STINE SEED FARM, INC. and MONSANTO TECHNOLOGY LLC, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said invention in all countries.


