**ASSIGNMENT AND AGREEMENT**

*WHEREAS*, **Schunkichi SASAKI** of Okayama-shi, Okayama-ken, Japan; **Yasuhiro TAKEBAYASHI** of Okayama-shi, Okayama-ken, Japan; **Satoru TAKAHASHI** of Kyoto-shi, Kyoto-fu, Japan; **Tatsushi YONEZAWA** of Nagaokakyo-shi, Kyoto-fu, Japan; **Masaki SUGIHARA** of Hikawa-gun, Shimane-ken, Japan and **Yoshikazu HIRAI** of Ohtsu-shi, Shiga-ken, Japan; (hereinafter referred to singly and collectively as "ASSIGNOR") have invented a certain invention entitled **PUSH-BUTTON SWITCH** (Atty.
