


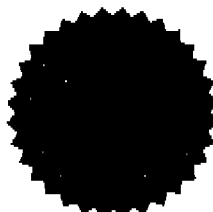

SCIENTECH, Inc., a corporation organized and existing under and by virtue of the Delaware General Corporation Law (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: The Corporation filed its Amended and Restated Certificate of Incorporation with the Secretary of State of the State of Delaware on January 8, 2001.

SECOND: The Board of Directors of the Corporation has adopted a resolution proposing and declaring advisable an amendment (the "Amendment") to Article I of the Amended and Restated Certificate of Incorporation of the Corporation, which as amended, shall read as follows:

ARTICLE I

The name of the Corporation is SCCH, Inc. (referred to as the "Corporation")

THIRD: The Amendment was consented to and authorized by the holders of a majority of the Corporation's issued and outstanding Common Stock and 8% Cumulative Redeemable Preferred Stock, voting as separate classes, by written consent dated June 30, 2004 in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

FOURTH: The Amendment has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
