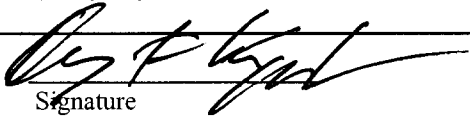

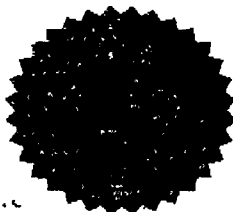

"The Name of this Corporation is Crossvue, Inc.

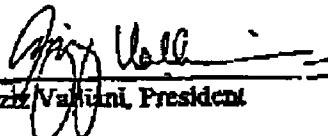
3. The foregoing amendment of the Second Amended and Restated Certificate of Incorporation has been duly approved by the Board of Directors of the Corporation.

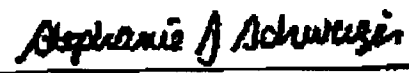
