ASSIGNMENT OF U.S. PATENTS

WHEREAS, **PricewaterhouseCoopers Inc., in its capacity as Receiver of Revolve Technologies Ltd.**, ("Revolve") (hereinafter referred to as Assignor), is desirous to sell assign and transfer Revolves entire right, title and interest, whatever that may be, in and to the United States Letters Patents and the inventions described in the Schedule attached hereto;

NOW, THEREFORE, pursuant to a Bill of Sale and Agreement between the above parties dated March 7, 2000, and in consideration of One Dollar and other good and valuable considerations, the receipts of which is hereby acknowledged, and said Assignor has sold, assigned and transferred, and by these presents does sell, assign and transfer unto Assignee, its successors and assigns, Revolve's entire right, title and interest, whatever that may be, in and to the inventions as described in the aforesaid Letters Patents, and any divisions of continuations thereof and the inventions therein disclosed and any improvements thereof, and any patent or patents that may be issued or reissued thereon, the same to be held and enjoyed by the Assignee for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives to the full end of the term for which the Letters Patents have been granted or may be granted, as fully and entirely as the same would have been held and enjoyed by the Assignor, if this assignment and sale had not been made; together with all claims Revolve may have for damages by reason of infringement of said Letters Patents, with the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives; Assignor hereby authorizes the

Assignee, its successors and assigns, to file in its own name applications for patents in foreign countries in connection with the inventions hereby transferred, under the International Convention claiming the priority of the United States applications or otherwise, and to secure in its own name the patent or patents issued thereon; and Assignor hereby agrees that, upon request of the Assignee, and at the expense of the Assignee including the fees and disbursement of PricewaterhouseCoopers Inc., it will sign all papers, and make all rightful oaths, and do all acts which the Assignee, its successors or assigns, may consider necessary in connection with the United States applications, and in connection with any other United States or foreign applications that may be filed in connection with the inventions as set out in the attached Schedule, and with any improvements thereon, and in connection with any patents issues or reissued thereon.
