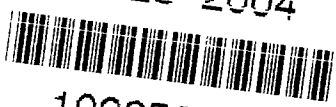

A S S I G N M E N T

Patent of the United States upon the above specifically identified application for said invention to Shakespeare Company, LLC, aforesaid, as assignee of our entire right, title and interest in and to the same for the sole use and behoof of our assignee, its successors and assigns.

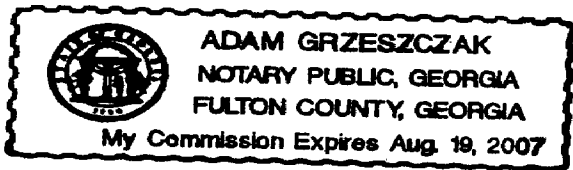
