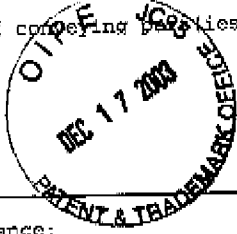

ASSIGNOR also hereby sells, assigns and transfers to ASSIGNEE and its successors, assigns and legal representatives all right, title and interest in, to and under the inventions described in the Application and, if any, Future Patents throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for such inventions in ASSIGNEE's own name throughout the world, including all rights of priority, all rights to establish cautionary notices reserving ownership of such inventions, and all rights to register such inventions in appropriate registries; and ASSIGNOR further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith reasonably necessary to perfect such right, title, and interest in ASSIGNEE and its successors, assigns and legal representatives.

ASSIGNOR does hereby further agree that it will, at the expense of ASSIGNEE, testify in any legal proceedings, sign all lawful papers, execute all counterparts, divisional, continuation, continuation-in-part, reissue, reexamination, and substitute applications, make all lawful oaths, and generally do everything possible to vest title in ASSIGNEE and to aid ASSIGNEE and its successors, assigns and legal representatives in obtaining and enforcing proper protection for the Application and, if any, Future Patents in such countries as ASSIGNEE may elect.
