AND ACKNOWLEDGEMENT THEREOF**

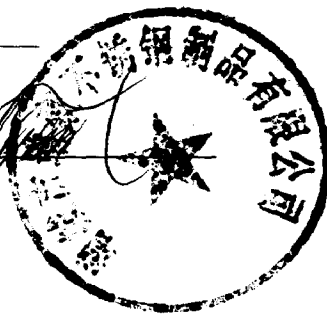
