ASSIGNMENT



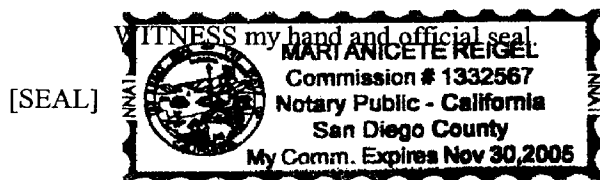

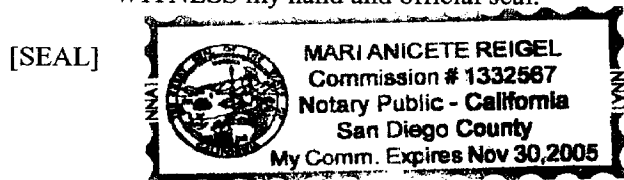
