

**RELEASE OF SECURITY INTEREST**

WHEREAS, **ZEUS SEMICONDUCTOR, INC.**, an Oregon corporation, **formerly known as CALDUS SEMICONDUCTOR, INC., formerly known as 3C SEMICONDUCTOR CORPORATION**, whose address is Suite 230, 600 SE Assembly Avenue, Vancouver, Washington 98661 (hereinafter collectively referred to as **ZEUS**), has made certain inventions in the field of semiconductors; and

WHEREAS, **CASCADIA PACIFIC II, LLC**, an Oregon limited liability company, whose address is Lincoln Tower, Suite 740, 10260 SW Greenburg Road, Portland, Oregon 97223 (hereinafter **CASCADIA**) has entered into an agreement dated August 1, 2002, with **ZEUS** and **ZEUS** executed a Promissory Note promising to pay to **CASCADIA** the principal sum \$83,500.00 (Eighty-three thousand five hundred dollars) plus interest and subsequent fees and costs incurred;
