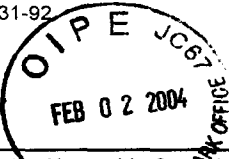

**AUTHORITY**

This Agreement, entered into and effective this *22nd* day of *SEPT.* 2003, by and

**BETWEEN:** **ALCAN INTERNATIONAL LIMITED**, a Canadian Corporation having a principal place of business at 1188 Sherbrooke Street West, Montreal, Quebec, Canada H3A 3G2 ("AlcanInt)

**AND** **ALCAN ALUMINIUM UK LIMITED** a company registered in England under number 750143 having an office at Hunton House, Highbridge Estate, Oxford Road, Uxbridge UB8 1 HU ("AAUK")

**WHEREAS**

- A** AAUK and Boxitgorsky Glinozern Open Joint Stock Company ("BG") entered into a sale agreement in the form annexed hereto ("the Agreement") on 18 April 2003.
- B** AlcanInt is the proprietor of the patents ("the Patents") and trade marks ("the Trade Marks") described in Schedules 1 and 2 of the Agreement.
- C** The Patents and the Trade Marks constitute "locally owned technology" as defined in the agreement between AlcanInt and various companies of the Alcan Group including AAUK for the Joint Research and Technical Services in connection with Aluminium ("the JTA").
- D** The Agreement sets out certain statements and obligations ("the Obligations") by AAUK in respect of the Patents and Trade Marks and AlcanInt desires to authorise AAUK to carry out all acts necessary on behalf of AlcanInt in order for AAUK to meet its Obligations and further AlcanInt delegates its rights in respect of the Patents and Trade Marks under the JTA absolutely to AAUK.

**NOW THEREFORE**

In consideration of one pound (£ 1) hereby paid by AAUK to AlcanInt (the receipt of which AlcanInt hereby acknowledges) AlcanInt hereby:

- 1 authorises AAUK to carry out all acts necessary on behalf of AlcanInt for AAUK to meet the Obligations; and
- 2 delegates its rights and obligations under the JTA to AAUK in respect of the Patents and the Trade Marks and AAUK accepts such rights and obligations, such that all rights, title and interest in the Patents and the Trade Marks will be transferred and/or licensed to BG in accordance with the Agreement.
