to the date hereof in the sum of \$ 11,643, and attorney's fees in the sum of \$ 33,062

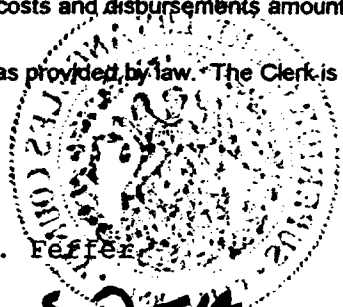
total of \$ 544,705 with plaintiff(s)/cross-complainant's(s) costs and disbursements amounting
