

The Assignor also has sold, assigned, and transferred, and do hereby sell, assign and transfer to the Assignees, its successors and assigns, their entire right, title and interest in and to the invention disclosed in said applications, in all countries of the world foreign to the United States, including the right to file applications and obtain patents for said inventions in its own name in said countries and including all rights of priority in said countries under the terms of any applicable international convention; to have and to hold for the sole and exclusive use and benefit of the Assignees, its successors and assigns, to the full end of the term or terms for which any and all of said Letters Patent for said invention may issue, to the same extent as the Assignor would hold and enjoy if this Assignment had not been made.

The Assignor further agrees to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such patent rights, and also agree, at the request of the Assignees, to testify in any legal proceedings, sign all lawful papers, make all lawful oaths, and generally do everything possible to aid said Assignees, its successors and assigns, to obtain, maintain and enforce patent protection for said invention in all countries.
