ASSIGNMENT

WHEREAS, Jeusworld Corp. (hereinafter, together with any successors, legal representatives or assigns thereof, called "Assignor"), a corporation organized under the laws of the state of Republic of Korea is the owner of certain new and useful improvements disclosed in an application for United States Letters Patent titled Marketing Lottery Card and On-Line Marketing Method Using the Same, application serial number 10/185,677, filed June 27, 2002;

AND said Assignor HEREBY covenants that said Assignor has full right to convey a fifty percent (50%) undivided interest herein assigned, and that said Assignor has not executed, and will not execute, any agreement in conflict herewith;
