

AND, furthermore the Owner covenants and agrees with the Assignee, its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by the Owner and that full right to convey the same as herein expressed is possessed by the Owner.




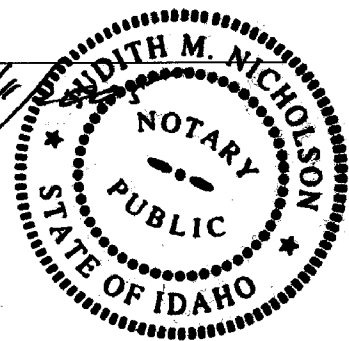
