In consideration of the payment of One Dollar (\$1.00) in United States currency made by Assignee to Assignor and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, as owner of the entire right, title, and interest in and to certain United States Letters Patents and certain applications for United States Letters Patent, and the inventions described and claimed therein, as set forth in Schedule A attached hereto and made a part hereof (hereinafter collectively referred to as "Polymer Modifiers Patents"), does hereby sell, assign, and transfer unto Assignee, its successors and assigns, all of the right, title, and interest which Assignor owns in and to the Polymer Modifiers Patents, and any divisions, continuations, continuations-in-part, extensions, and reissues thereof; and Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any original or reissue Letters Patent in and to any or all of the Polymer Modifiers Patents to Assignee or its successors and assigns; and hereby authorizes Assignee, its successors and assigns, to file applications for corresponding Letters Patents in any foreign country or jurisdiction and to secure in its own name the Letters Patent or Letters Patents issued thereon, the same to be held and enjoyed by Assignee, its successors and assigns, for the full term for which such Letters Patents are granted, as fully and entirely as the same would have been held and enjoyed by Assignor had this sale, assignment, and transfer not been made.
