

AND MONSANTO TECHNOLOGY LLC, ITS SUCCESSORS, LEGAL REPRESENTATIVES AND ASSIGNS, THE ENTIRE RIGHT, TITLE AND INTEREST IN, TO AND UNDER THE SAID INVENTION, AND THE SAID APPLICATION AND ALL DIVISIONS, RENEWALS AND CONTINUATIONS THEREOF, AND ALL LETTERS PATENT OF THE UNITED STATES WHICH MAY BE GRANTED THEREON AND ALL REISSUES AND EXTENSIONS THEREOF, AND ALL APPLICATIONS FOR LETTERS PATENT WHICH MAY HEREAFTER BE FILED FOR SAID INVENTION IN ANY COUNTRY OR COUNTRIES FOREIGN TO THE UNITED STATES, AND ALL LETTERS PATENT WHICH MAY BE GRANTED FOR SAID INVENTION IN ANY COUNTRY OR COUNTRIES FOREIGN TO THE UNITED STATES AND ALL EXTENSIONS, RENEWALS AND REISSUES THEREOF AND ALL RIGHTS OF PRIORITY IN ANY SUCH COUNTRY OR COUNTRIES BASED UPON THE FILING OF THE SAID APPLICATION FOR LETTERS PATENT OF THE UNITED STATES WHICH ARE CREATED BY ANY LAW, TREATY OR INTERNATIONAL CONVENTION; AND WE HEREBY AUTHORIZE AND REQUEST THE COMMISSIONER OF PATENTS OF THE UNITED STATES, AND ANY OFFICIAL OF ANY COUNTRY OR COUNTRIES FOREIGN TO THE UNITED STATES, WHOSE DUTY IT IS TO ISSUE PATENTS ON APPLICATIONS AS AFORESAID, TO ISSUE ALL LETTERS PATENT FOR SAID INVENTION TO THE SAID STINE SEED FARM, INC. AND MONSANTO TECHNOLOGY LLC, ITS SUCCESSORS, LEGAL REPRESENTATIVES AND ASSIGNS, IN ACCORDANCE WITH THE TERMS OF THIS INSTRUMENT.
