

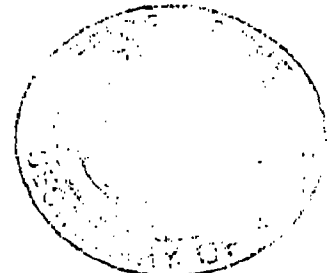
4. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors.

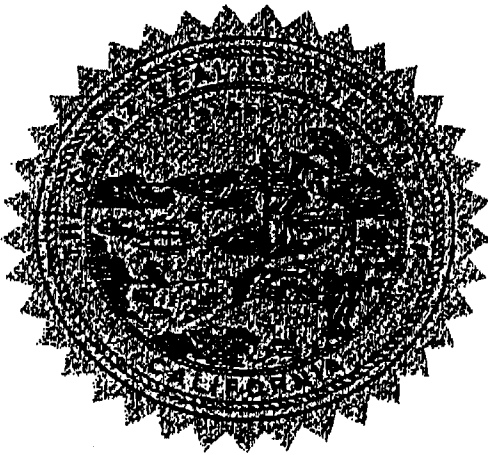
