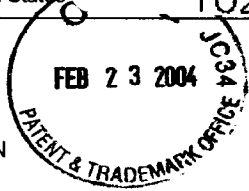

THIS ASSIGNMENT, by BENGT SAHLBERG, JOHAN SJÖHOLM, ERNST WEHTJE, AND PER-OLOF ERLANDSSON, residing at LUND, SWEDEN; LUND, SWEDEN; MALMÖ, SWEDEN; AND SÖDRA SANDBY, SWEDEN (hereinafter referred to as "the Assignors"), respectively, witnesseth:

WHEREAS, the Assignors have invented certain new and useful improvements in MOISTURE SENSOR set forth in an application for Letters Patent of the United States,



