PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT ("Assignment") is made effective as of November 8, 2000, by and between DYNISCO, INC., a Delaware corporation ("Assignor"), and DYNISCO INSTRUMENTS LLC, a Delaware limited liability company ("Assignee").

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as owner of the Patents, including any continuations, divisions, continuations-in-part, renewals, reissues, reexaminations, revisions, extensions or foreign equivalents thereof, and to issue any and all letters patent of the United States thereon to Assignee, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

Assignor hereby represents and warrants that its right, title and interest in and to the Patents set forth on Schedule A are free and clear of any liens and encumbrances, that it has full right to assign all of its interests therein, and that it has not executed and will not execute any agreement or other instrument in conflict herewith.
