**ASSIGNMENT DEED**

**THIS DEED** is made the 4<sup>th</sup> day of February 2004

**BETWEEN**

- 1.3 the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of all infringements of the Registered Design whether committed before or after the date of this Agreement

**TO HOLD** the same unto the Assignee absolutely.

2 The Assignor agrees that, at the request and cost of the Assignee they will at all times hereafter do all such acts and execute all such documents as may be reasonably necessary or desirable to secure the vesting in the Assignee of all the right assigned to the Assignee hereunder and to assist in the resolution of any question concerning any of the same.
